Dear Residents and Families/Representatives,

Please accept this letter as our weekly update regarding the status of COVID-19 in our facility. There are currently no residents with confirmed cases of COVID-19 in the facility. There has been a total of 98 residents who have tested positive from the 100% testing of all residents that began on 6/29/20. 50 employees have tested positive for COVID-19 since employee testing started on 7/1/20.

Our 3rd and final Walgreens Mobile Pharmacy COVID-19 Vaccination Clinic will be held at Spanish Trails on Thursday, February 25th.

The Spanish Trails Team continues to work with Curative, a COVID-19 testing company, to test residents and staff weekly in accordance with the New Mexico Department of Health guidelines and the current greater than 10% county positivity rate for Bernalillo County. With respect to the local county positivity rate, the COVID-19 positivity rate for Bernalillo County continues to decline, standing at 4.7% as of February 10th.

In addition to Curative support, we also have rapid testing equipment in the facility which allows us to test both residents and staff and obtain COVID-19 results within approximately 15 minutes.

We continue to keep our residents in communication with their families via regular window visits and video/face time calls with their loved ones. We are making every effort to keep our residents engaged during this 2nd wave of COVID-19 and responding to their requests and preferences as timely as possible.

Please continue to check our website for weekly updates as well as notification of new cases. As always, we will notify you if we receive confirmation of a new positive case in our facility and we will reach out to you individually if your loved one is displaying symptoms of COVID-19 or tests positive for COVID-19.

Please accept this letter as our weekly update regarding the status of COVID-19 in our facility. As of today, there is 1 resident who has tested positive for COVID-19 in the facility. There has been a total of 98 residents who have tested positive from the 100% testing of all residents that began on 6/29/20. 49 employees have tested positive for COVID-19 since employee testing started on Wednesday, July 1st.

Our 3rd and final Walgreens Mobile Pharmacy COVID-19 Vaccination Clinic will be held at Spanish Trails on Thursday, February 25th.

In our continued campaign to improve the dining services experience for our residents, we have implemented "taste testing" trays whereby several residents will be able to sample the day's menu options prior to meal service. It is our hope that this resident-involved quality audit will help us identify opportunities for improving the quality, preparation, and delivery of the dining services experience at Spanish Trails.

The Spanish Trails Team continues to work with Curative, a COVID-19 testing company, to test residents and staff weekly in accordance with the New Mexico Department of Health guidelines and the current greater than 10% county positivity rate for Bernalillo County. With respect to the local county positivity rate, the COVID-19 positivity rate for Bernalillo County continues to decline, standing at 6.7% as of February 2nd.
